## **Results of ICGN Annual General Meeting 2023**

Held in a hybrid format with all Members attending in person or online via the UK Engage platform, on **Wednesday 20th September 2023 at 14:45 - 16:45 BST.** 

A poll was held on each of the resolutions proposed and the results of the poll are set out below. Each resolution was passed. A total of 39 Lead Members voted on AGM resolutions, of which 27 cast their votes in advance of the AGM and 12 cast their votes at the live meeting. Of the total votes cast, three were via proxy.40 people attended the AGM.
